


Residential Work Release



WCWR has had 158 individual intakes this year, including 3 CTP referrals. The highest ADP was in September with 72.60.

2021 ADP = 59.07 Jail Sentence – 56.96 Pretrial – 2.11

INTAKES BY OFFENSE



The goal of successful completion or modification of a sentence is often met upon exit, however, terminations occur for various reaons. There were 143 exits recorded with the following completion status:

Successful completions	91 (64%)
Termination for conduct	15 (10%)
Modification of sentence	9 (6%)
Termination for positive UA	7 (5%)
Self-termination	6 (4%)
Escape / Abscond	4 (3%)
Other (employment terminated,	
warrant, furlough, medical)	11 (8%)


Whitley County Community Corrections and Probation define recidivism as any new conviction within five years of the participant / offender being released from any level of court supervision. The Residential Work Release six-month rate is 6%; the 30-month recidivism rate for all community-based supervision programs, including probation, is 21%.

Home Detention

HD had **65 intakes** this year with 41 (63%) being sentenced in Whitley County.

12 (18%) were courtesy supervision from other counties and 2 (3%) were pretrial supervision. A total of 7 adult cases were transferred out of county for HD supervision.


A total of 8 (15%) juveniles were supervised in 10 cases this year.

Face-to-face and telephone contact with Home Detention participants are based on risk level according to the Indiana Risk Assessment System (IRAS) scores. Staff completed the following contacts throughout the year.



Home Detention Completions

80% of adult participants and 82% of juveniles successfully completed the home detention program.

Employment Services Program

88 individuals participated in the Employment Service Program in 2021 100% were employed with 14 days

30 Residential Work Release participants employed prior to intake

32 employers in Northeast IN hired WCCC participants this year



WCCC partnered with the Whitko Career Academy and Community Foundation Whitley County to enable individuals to participate in advanced career training.

After 12 weeks of classes and hands-on training, five individuals from Residential Work Release and the Veterans Treatment Court successfully graduated with their CNC certification.



Alcohol & Drug Forensic Diversion Program

The Alcohol & Drug Forensic Diversion program continues to provide direct service to residents of Whitley County and surrounding counties, as well as case management for those out of state as ordered. Program services were provided to 413 new clients this year.





Veterans Treatment Court













A total of 23 Veterans participated in Veterans Treatment Court this year with **6 graduating** from the program.

Oftentimes Veterans request information for the program and do not request screening. This year 34 Veterans requested information, however only 10 requested screening; all were found eligible for the program. Veterans Treatment Court has Memorandums of Understanding with Huntington and Kosciusko Counties. Nine Veterans were provided services through courtesy supervision this year, and three were transferred to other counties for supervision.



The Average Daily Population for VTC has increased from 11.10 to 16.29 throughout 2021.

Community Service




Community Service continues to schedule individuals to work specific days and times in response to COVID-19. In 2021, a total of 11,603.10 hours were logged, with 6777.75 of those hours worked in Whitley County agencies. In total, individuals contributed \$84,122.49 in labor to the communities in northeast Indiana this year.


Pretrial Services

Length of Supervision (Days by Level of Offense)

Pretrial Services (PTS) staff work with defendants to maintain appointments and follow through with court orders to promote successful supervision. The team monitored **566** cases in 2021 with a **94.84% appearance** rate (percentage of defendants who complete supervision with no FTAs).



PTS CASE CLOSURES



Defendants are supervised according to risk based on a predetermined matrix with many of the defendants scoring low risk.

Successful completions by risk (345 total):

High Risk – 5% Moderate Risk – 39% Low Risk – 56%

Failure to complete by risk (47 total):

High Risk – 19% Moderate Risk – 51% Low Risk – 30%

Making Sense of Your Worth	6	42	84 hrs.	An 8-week class was presented by Live. Heal. Grow. Counseling on Positive Self-Worth for 8 women in RWR.
Domestic Violence MRT	26	167	784+ hrs.	This 24-step class is held weekly and includes referrals from HD, RWR, Prob, and the Courts. 19 new referrals were received, and 16 individuals successfully completed the program.
MRT	50	287	1500+ hrs.	Two classes of MRT are conducted weekly to include referrals from HD, RWR, Prob, and VTC. 31 new referrals were received, and 19 individuals successfully completed all 12 steps of the class.
Trauma MRT	4	24	24.33 hrs.	Trauma MRT is an 8-session trauma- informed care recovery program that was completed by 3 women within Residential Work Release.
Parenting Class	6	6	6 hrs.	Classes were restarted in December by Before 5 Parenting. 3 men and 3 women from Residential Work Release participate in the monthly program to focus on their parenting skills.
Project Victory	52	52	147+ hrs.	Project Victory is an in-house, volunteer, mentoring program for both men & women participants led by staff. It began in January 2021 and has grown to include a monthly alumni dinner, a 24-hour access phone and email for alumni, and a podcast.
Seeking Safety	9	118	181+ hrs.	4 men completed this 17-session trauma/addictions focused class on October 14, 2021. A second class is currently in process with 5 men scheduled to complete on March 14, 2022.
Where Does Your Money Go?	3	6	6 hrs.	Financial class presented by Purdue Extension. 3 men from Residential Work Release completed this program.
