1. 24-W-SUBD-18 "Zumbrun Minor Subdivision"

Brandon Zumbrun and Beckett Zumbrun, owners of the subject property, are requesting preliminary plat approval for a one-lot subdivision to be named "Zumbrun Minor Subdivision." The proposed plat is located on the north side of 200 South, 2,000' east of SR 5, in Section 16 of Richland Township.

The property is located on the north and south side of Yellow River Road, 1/4 mile southeast of Lincolnway. More commonly known as 6366 E. Yellow River Road, in Section 23 of Union Township.
