You have been placed on probation for _____. The Following are conditions of your probation. If you fail to comply with them, your probation may be revoked.

1. You shall obey all laws of the City, County, State, and Federal Govt.
2. You shall waive extradition to the State of Indiana and voluntarily return to this state and appear before the Court when so ordered by the Court.
3. You shall obtain permission from the Court before leaving the State of Indiana.
4. You shall work faithfully at a suitable employment, faithfully pursue a course of study or vocational training that will equip you for a suitable employment, or make every effort to obtain employment.
5. No alcohol or drugs are to be consumed or possessed, unless medication is prescribed by a physician. Any request for a substance abuse test must be submitted to and you are responsible for the cost of such test. You shall not consume hemp products.
6. You shall not possess drug paraphernalia or any devices for the ingestion of illegal substance into the human body.
7. When requested, you shall take a breathalyzer, intoxilyzer, alcosensor, or urinalysis, or any chemical test for the detection of any illegal substance. A failure, refusal, or tampering with sample is a violation. Two dilute specimens will be considered a violation.
8. You shall waive your right against search and seizure, and permit the Probation Officer or any law enforcement officer acting on Probation Officer's behalf to search your person, residence, motor vehicle, or any location where your personal property may be found, to insure compliance with probation.
9. You shall permit your probation officer to visit you at reasonable times, at your home, school, work, and elsewhere.
10. You must notify the Probation Office within 48 hours of any employment, residence, telephone changes, and/or any contact with law enforcement. You must cooperate with any ongoing investigation by law enforcement.
11. You may operate a motor vehicle only if you have a valid driver's license.
12. You shall report to your Probation Officer when requested.
13. You shall not associate with anyone who is violating a criminal law.
14. You shall not enter into any establishment where alcoholic beverages are the primary product for sale. This includes liquor stores, bars, taverns, and pubs.
15. You shall not use, purchase, receive, or possess a firearm, ammunition, destructive device, or deadly weapon.
16. If you violate a condition of probation during the probationary period, a petition to revoke probation may be filed before the earlier of the following:
 - (A) One (1) year after the termination of probation.
 - (B) Forty-five (45) days after the state receives notice of the violation.
17. You shall support your dependents and comply with any Court order of support.
