## **Employment Statistics in Whitley County**

According to data reported by Northeast Indiana Works, Whitley County is expected to see an increase of 25% in the labor market for the manufacturing sector. Increases are also projected in such areas as Wholesale Trade, Construction, Transportation and Warehousing.

The EDC data and data from the Indiana Department of Workforce Development shows that in our

area, manufacturing makes up 10% of our area businesses, employs 40% of our workers, and provides 65% of wages in Whitley County.

Manufacturing is a driving force in the economy in Whitley County. This data goes on to show that in our region, based on total occupations, there will be 108,442 projected job openings by the year 2022, with 32,235 projected openings due to economic growth, and 76,207 openings due to retirements and replacements.
