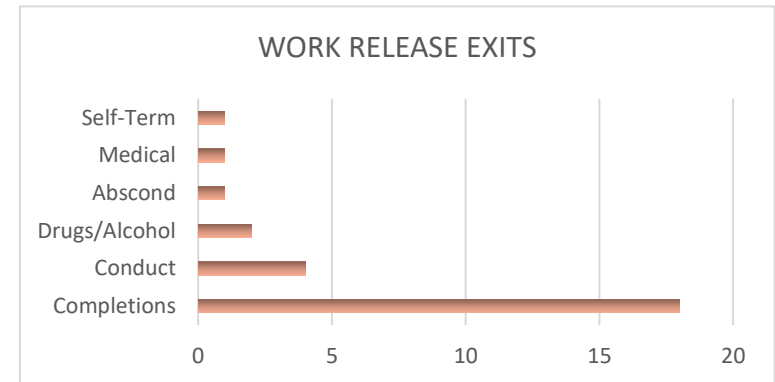

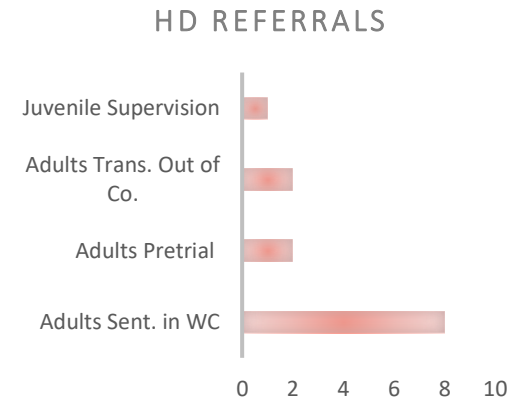
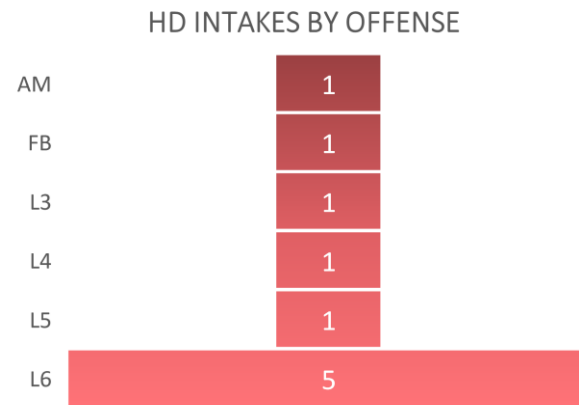
There were a total of 18 successful program completions from Work Release during Q1 (this does not include any modifications to a lesser level of supervision).

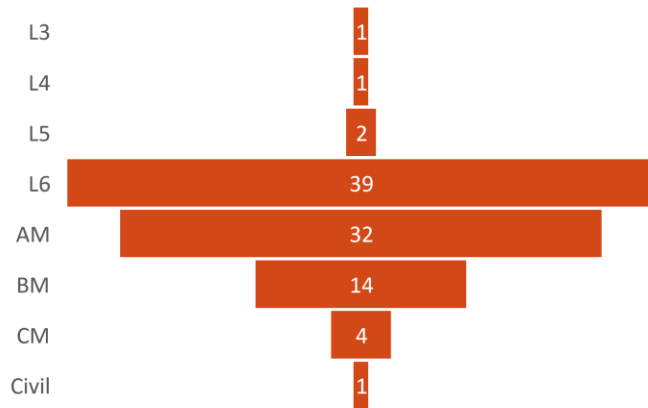
As COVID-19 numbers have decreased restrictions have lessened, adult Home Detention numbers have started to decrease slightly while juvenile numbers have increased.



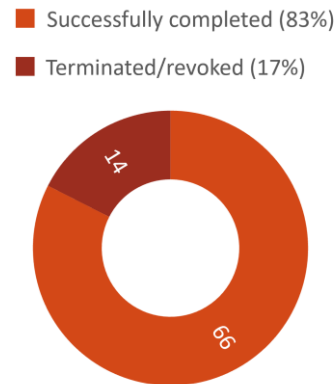
FORENSIC DIVERSION

FD received **94 new referrals** this quarter, up from 80 referrals Q4.
59% of new referrals fall into the individual poverty level (up from 26% Q4) with
27% unemployed.

1 referral was a **Class A Misdemeanor**

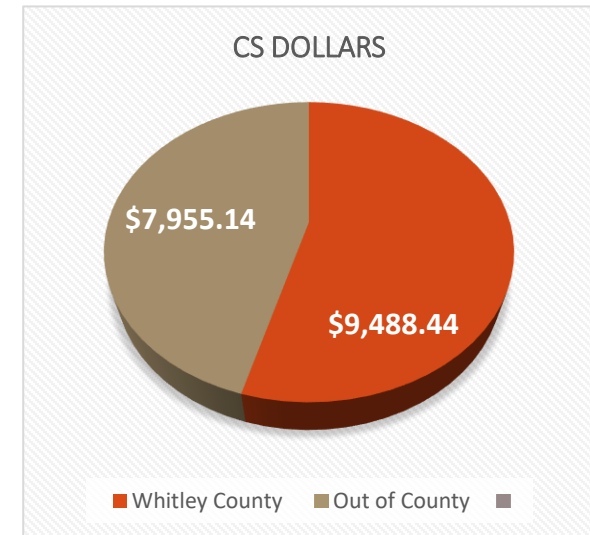
COMPLETIONS

COMMUNITY SERVICE

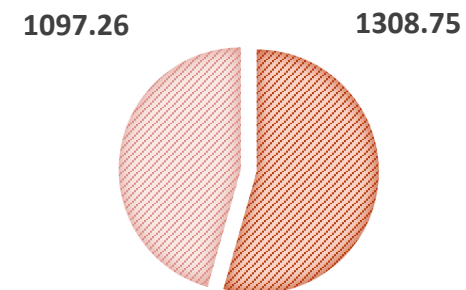
CS continued to limit crew participation for individual safety this quarter.

■ Whitley County Hours ■ Out of County Hours

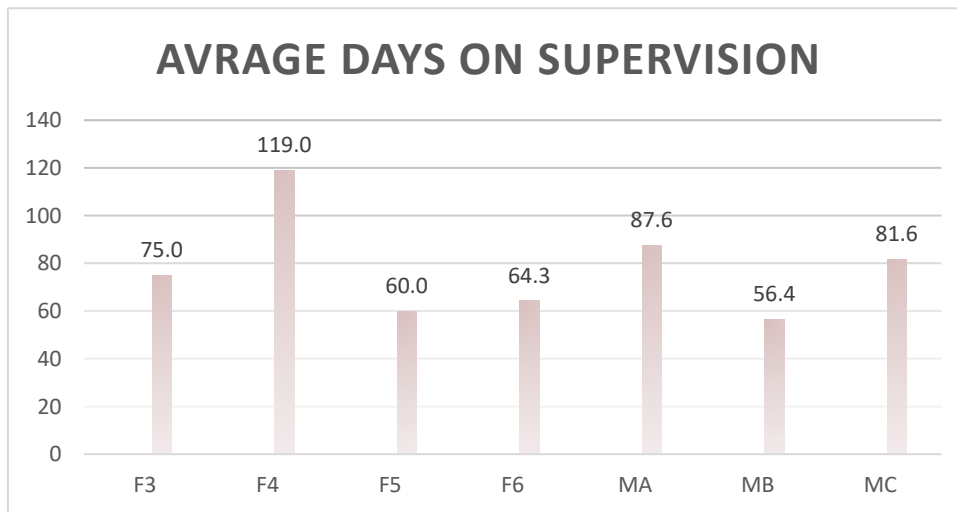

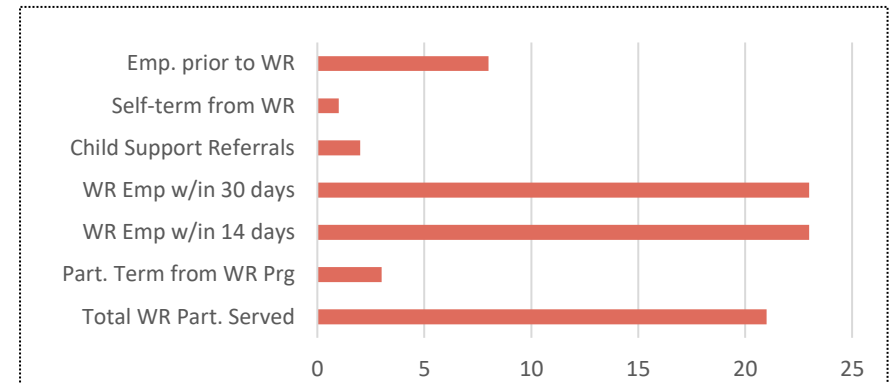
PRETRIAL SERVICES

Pretrial services supervision this quarter has increased from only misdemeanors and Level 6 felony offenses to include offense Level 3 - Level 5 felony.



EMPLOYMENT SERVICES

The ESC continues to work with all referrals for those who need employment. The number employed within 14/30 days exceeds the number served as participants are not required to repeat the program they have recently completed it. Currently, 100% are employed within 7 days of entrance to Work Release.

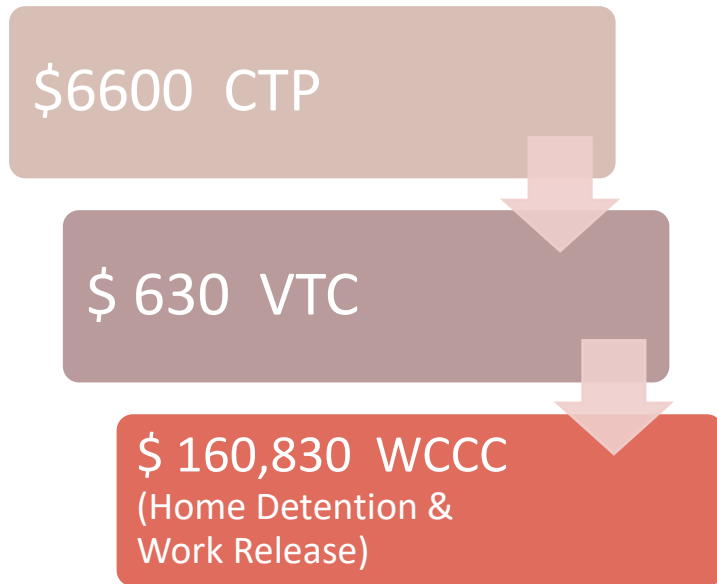


The **Safety Rate** for Q1 (percentage of defendants who complete supervision with no new offenses) is 93.85%
