

## WHITLEY COUNTY COUNCIL

*Revised* January 4, 2022

The Whitley County Council met in regular session at 8:00 am on Tuesday, January 4, 2022, in the Commissioner's Room located on the first floor of the Whitley County Government Center. Members in attendance were Vice Chair Kim Wheeler, Timothy Kumfer, Thomas Warner, James Argerbright, Joan Western and John Barrett. Others in attendance were Commissioner Chad Banks, Commissioners Assistant Cami Hippenhammer, HR Director Jennifer Shinabery, Chief Deputy Auditor Tamela Tincher, Chief Deputy Jason Spencer, Treasurer Kay Gatton, Recorder Rosemary Brown, Assessor Kim Erdly, Highway Director Katy Fry, Planning Director Nathan Bilger, Mary Hartman from Peabody Public Library and Robert Schuman.

Vice Chairman Wheeler called the meeting to order and led the group in the Pledge of Allegiance.

**IN THE MATTER OF THE ELECTION OF OFFICERS:** Councilman Warner nominated Council Kumfer for Chair, with a second by Argerbright, passing with a 6/0 vote. Councilman Argerbright made a motion to keep Councilman Wheeler the Vice Chair seconded by Western passing with a 6/0 vote.

**ORDINANCE FOR UNDER \$25 TAX PAYMENT:** Treasurer Kay Gatton presented Ordinance 2022-01 which would allow for tax payments under \$25 to be made in one installment. Councilman Warner made a motion, with a second by Western, passing with a 6/0 vote.

Councilman Warner made a motion to approve all encumbrance request, seconded by Western and passed with a 6/0 vote.

**SHERIFF DEPARTMENT TRAVELERS CHECK:** Chief Deputy Jason Spencer was present to ask that the Travelers insurance check be put into Cum Cap from a total loss vehicle. Councilman Wheeler said that he believes the Sheriff's Department needs to pay for cars out of the LOIT tax not Cum Cap. Funds are already in Cum Cap Council just needs to make a motion to approve the use of these funds. Chair Kumfer has stated Council wants to table until February meeting.

**ORDINANCE 2020-12 AMENDMENTS:** Council voted at the December 2021 meeting to give Scott Wagner a \$6,000 COVID compensation so we need to update the salary ordinance to reflect that change. Councilman Argerbright made a motion to approve, with a second by Warner, passing with a 6/0 vote.

**ORDINANCE 2019-11 AMENDMENTS:** HR Director Jennifer Shinabery was present to discuss changes made to Ordinance 2019-11 so that excluded employees can earn compensatory and overtime. Jennifer also updated the ordinance by changing some of the information to better suit Whitley County and our policies. Council woman Western made a motion, seconded by Wheeler passing with a 6/0 vote.

**HIGHWAY FOREMAN POSITION DISCUSS:** HR Director Jennifer Shinabery was present to discuss upcoming changes in the Highway Department. The County would like to eliminate the highway assistant director position and put back in place the foreman position. Reorganization is necessary and the Commissioners feel a foreman is needed. Councilman Wheeler made a motion to approve the request with a second by Warner, passing with a 6/0 vote.

**LONGEVITY PAYDATE DISCUSSION:** Chief Deputy Auditor Tamela Tincher was present to ask that we change the longevity pay date from November 2022 to January 2023, and moving forward paying out in January. Commissioner Banks would like to look at the policy manual. Motion to table by Wheeler to understand the policy better.

**IN THE MATTER OF THE 2021 BOARD APPOINTMENTS AND ASSIGNMENTS:** The Council reviewed the 2022 Board Appointments and Assignments. John Barrett would like to continue to serve on the JDAI board. No changes were made for the 2022 Board assignments. Chair Kumfer would like to table until February meeting.


**IN THE MATTER OF THE COMMISSIONER'S REPORT:** Commissioner Banks gave a report from the Commissioner meeting:


- Commissioner Banks informed the Council that he will be the Chairman for 2022 and Commissioner Green will be the Vice Chair.
- There was a discussion to use CEDIT dollars to cover EMS services. Commissioners would like to use \$125,000 from CEDIT to cover for 2020-2021 payments. The Community Foundation pays for a portion from their trust and the County covers the rest. Wheeler made a motion to allow Commissioners to use on/off site for EMS. With a second by Western, passing with a 6/0 vote.
- Chad Nix was present to present some projects to the Commissioners for use of ARP funds. Commissioners are considering this, but Banks would like to have a meeting of the ARP committee.
- Health Director Scott Wagner gave an update from a public health standpoint.
- In December the Commissioners signed contracts for an owner's rep and an architect to get the jail project rolling.
- Commissioners are exploring having an on-call engineer to cover the vacant position. Commissioner Banks doesn't feel that we need a full-time engineer as the last 5 years we have had a part-time engineer. The Commissioners have thought about a split Engineer between the city and county.


